Secretary/Treasurer Report

February 22nd, 2017

Welcome and Introductions

The meeting started at 12:57 pm with 1st Vice President Satoru Persons presiding, he welcomed attendees to the meeting. Thomas Page led the attendees in reciting the Pledge of Allegiance.

Awards and Scholarship Committee

Mindy Lane – three awards to give out: Betty Riggs, Tricia White, Diana Ruble have been awarded \$600 for professional development, in recognition of the professionalism, work, and assistance to their communities. Each was awarded a certificate by Vice President Persons.

Mindy advised that the awards committee will open up for more nominations in the September October range keep tuned to the website.

Secretary Report

Mike Banks announced the chapter meeting minutes from the November meeting were posted on the Ohio APCO website and copies were available at the front table. Mike asked for a motion to waive the reading of the minutes. Patrick Brandt made the motion, seconded by Janet Boland, the motion carried with all in favor.

Treasurer Report

Mike Banks read off the current account balances for the Ohio APCO held accounts; APCO Checking \$21793.53; APCO Money Market \$29569.23; Gold Star \$32907.10 Lynne made the motion to accept the Treasurer's Report, seconded by Patrick Brandt. Motion carried with all in favor.

APCO Executive Council

Jay Somerville - there are a few important dates to keep in mind at the national level. APCO national committees are accepting applications through 4/1. Participating at the committee level with APCO can be very rewarding, it's critical that Ohio continues to participate in these committees

Credentials committee certified 1 candidate for 2nd VP, Tracy Hilburn (LA), and is the sole candidate for this position. Ms. Hilburn previously served as LA chapter president, Executive Council and has been very involved in APCO and NENA in Louisiana. An affirmative vote is

required to elect her into office even though she is unopposed. Also, the 1st Vice-President candidate, Holly Wayt (City of Westerville) requires an affirmative vote to be voted into this office, be sure to sign in to the APCO website to vote once polls open.

Aging in the Communications webinar is available on the website, it can be seen free of charge if you did not have an opportunity to participate in the January 24th teleconference.

APCO international and APCO Institute CPE program, two 12 week online courses, followed by 9 day in person class. Just completed their first round and requirements have changed. Previously required RPL, or college degree. Now open to anybody that has been a supervisor or director for a minimum of 10 years. Registration deadline approaching, April 15th for spring/summer and January courses. This course is on par with the PELC program or OFE program.

ASAP to PSAP protocol: A presentation will be held at the May chapter meeting. Membership is up at APCO national, total member 24468, about 3000 higher from same time period last year, expect it to go up as renewals come in through February.

Next emerging technology forum will be Feb 28th thru March 1st in Raleigh, NC APCO 2017 held in Denver. April 3rd is flash day, providing a \$100 discount on member full conference registration. APCO housing is first day for housing as well.

Nick Levine - the RFP for Ohio NG 911 project went out on Friday and is available on Ohio's procurement website and a link will be on the Ohio 911 program office website.

Subcommittee will meet soon regarding language in ORC 128

Rob Jackson will be at the APCO/NENA conference manning the booth for the Ohio 911 Program Office and delivering a presentation. Rob and Jay will be conducting a session on PSAP standards on what to expect in the audit process

Date of compliance with the PSAP rules is May 12, 2018. The will be a compliance and support position posted with the Ohio 911 Program Office on July 1st.

Bob Bill – CAPRAD training in April in the DFW area to aid in 700Mhz frequency applications. Rick Schmall with MARCS program office – encouraged attendees to reach out to their office for support with radio meetings and issues regarding the MARCS systems. A web interface will be available to update radios in the system replacing the old spread sheet.

Legislative Committee

Jay - nothing specifically brewing at the statehouse right now. The 911 Program Office has been collecting input from the PSAP ops committee on things to consider on updating ORC 128. A legislative push is expected in the end of the year to convert a wireless device fee to a universal device fee. Jay encouraged attendees to get in contact with legislators and involve and educate them about PSAP operations, issues, challenges, successes, employee milestones, etc. The RFP will be a huge component of what we'll accomplish with the legislature, they want to know that the device fees are the correct amount, the costs attributed to the RFP submissions will give them an idea of what the actual costs are and what the fee should be. There are a lot of new senators and representatives - now is the time to talk to them.

Jay Somerville, Holly Wayt, Lynne Feller, Matt Franke have been appointed to the nominating committee. They have recommended following slate of candidates: Pres. <u>Training Committee</u> – Lydia Frey has been asked for volunteers to assist with the training committee and training presentation selections for this and future conference needs..

2016 TELECOMMUNICATOR OF THE YEAR

SARAH MILLER - Wooster-Ashland Regional Dispatch

On September 13, 2016, Dispatcher Sarah Miller received a 9-1-1 call from a female advising she had been abducted and needed help. The captor was in the room with her and asleep at the time. The caller whispered to the dispatcher that she did not know exactly where she was other than she was in a yellow house near the 4th Street laundry in Ashland.

As units were being dispatched Dispatcher Miller asked about the circumstances of the abduction and a description of the suspect. The caller informed her they were in an abandoned house, she had been tied up but managed to free herself; he was armed with a taser. Dispatcher Miller worked to keep the victim calm and communicating, keeping in mind she could not speak louder than a whisper without waking up the suspect. There was no way for the caller to leave the room without waking the suspect. To make matters worse, arriving officers found two yellow abandoned houses next to each other in the location given by the caller.

As officers attempted to determine the correct location and prepare for entry, Dispatcher Miller did her best to keep the victim on the line and calm, advising her that help was outside. She told the caller to indicate when she saw officers outside the window so she could inform them they were surrounding the correct residence. Once the correct location was verified and the perimeter secured, officers made a swift entry into the house, rescuing the victim and apprehending the suspect who woke up as the officers made entry.

Without a doubt, the efforts of Dispatcher Miller and the Ashland Police Division's officers saved this victim's life. Unknown to the responders and victim, remains of two deceased women were discovered inside the vacant house. The suspect was charged with the murder of the two deceased women and is suspected in several other homicides of females in the region.

Dispatcher Miller's confident and cool demeanor throughout the call was key to the successful rescue of the victim and apprehension of an accused serial killer. The caller's fate would have been very different if she had not remained calm, if she could not be located quickly, and did not remain on the phone until officers made contact with her. Keeping the caller calm was key. Losing the element of surprise would have greatly increased the risk of further harm to the victim and potentially for the responding officers. With no successful conclusion to this call, the other victims, all of them missing persons, would have remained open cases and an undetected serial killer would remain free to commit further crimes.



2016 DOUBLE GOLD WINNERS Delaware County Sheriff's Office

On Sunday December 4, 2016 Dispatcher Scott Lill took a phone call from a female requesting a well being check on her brother. She told Dispatcher Lill that she received multiple calls from her brother requesting her to go to his house to take care of his children. He also stated his wife was not good. She was afraid he may hurt himself so she drove two hours to the house and found her two nieces, ages two and four, at home by themselves.

Because the caller did not want to say much in front of the children Dispatcher Lill had some difficulty getting the necessary information for responding units. The caller's spouse finally got on the phone to say the four year old just said that "daddy shot mommy in the car."

During this conversation Dispatcher Brittany Dowler searched the CAD system and LEADS for any information on the brother and his wife hoping to get a possible vehicle description or location where they might be. Additional checks in CAD revealed cellphone numbers for both the male and female. Dispatcher Dowler contacted the cell phone provider and requested a ping of their phones. Twenty-six minutes into the call a location was returned within a radius of 1180 meters, almost 3/4 of a mile. While her partners were tied up in their different attempts to get vital information Dispatcher Alisa Smith started units to the house to speak with the caller and children. Once the possible cell phone location was provided by the phone company she had other units from the Delaware County Sheriff's Office and officers from four other agencies respond to the designated area of the county in hopes of finding the male and female. A deputy located a vehicle matching the description of the brother's car in a parking area at one of the state parks in the county. After waiting for back up units, the deputy found a female in the passenger seat, deceased from a gunshot wound. Not knowing the location of the male, a canine was deployed and found a male subject along a path just north of the vehicle, also deceased from a gunshot wound. The teamwork and synergy displayed in the radio room during this incident exemplify the professionalism of each dispatcher involved. They performed their duties exactly as trained and worked towards the goal of locating the missing persons while keeping the responding officers safe.
